In the following statements, RiverTree Christian Church, Ripple FX, and event location personnel refers to all authorized adult sponsors with this program, both paid staff and volunteers.

Parental Consent Form/Release of Liability

1. I give permission for my student, named above, to attend and participate in this event and associated activities. In permitting my child to participate, I agree that such responsibility will remain with me, as parent and guardian of my child. While I understand that staff, volunteers and participating churches will take all reasonable steps to provide care and safety for my child, I am aware that all churches, their employees, volunteers, and agents cannot assume responsibility for injury, damage, or harm that might result during the course of the program.

2. I give permission for personnel to transport my student to and/or from the activities.

3. I give permission for personnel to make the necessary decisions in the event of a medical or dental emergency involving my child.

4. I/my child take responsibility for injury or damage to personal property as a result of my child's actions and assume all expenses incurred for said action(s), including but not limited to, medical, dental, emergency treatment, property loss, etc. Should any claim be asserted by any person as a result of the acts of my child while participating or traveling to or from any such activities, or should my child assert any claim against the organization, participating churches or any employees, volunteers, or agents, I agree to indemnify and hold harmless from any such claim, including (but not limited to) attorney fees and costs incurred in defense of.

5. I/my child understand(s) that he or she will abide by Christian principles under a covenant of good faith. If disciplinary action is required, we accept your right to refuse or terminate participation and, if necessary, assume full responsibility for returning my student home.

Student Ministry Dismissal Policy:

First, we never want to see a student sent home. We truly believe that students are at on this trip for a reason – to have their life impacted positively. Therefore, we only consider sending a student home from any trip/event as a last resort.

Second, as parents and guardians, we want you to know that we care deeply for all the students that come under our care and supervision.

Thirdly, we also want you to know that communication is important to us. If we do run into difficulty with your son or daughter consistently disregarding rules then we will contact you and brainstorm with you how to proceed.

Finally, we don't make too many rules. We try to make things simple for students and allow them to have fun and be safe. However, the rules we do have we enforce and we make sure we communicate the rules to students so there is no confusion.

These four ideas hopefully have given you an idea of our heart on the matter of dismissal. However rare, there are times when it becomes necessary for a student to be sent home. If this occurs, parents and guardians are responsible to provide transportation home for the student.

The sorts of things that would cause a student to be dismissed include:

- Student uses illegal drugs, alcohol, or tobacco.
- Student violates state or federal law (theft, assault, vandalism etc...)
- Student performs any act that endangers others, bullying, or continually disregarding safety.
